Disposition and Deed of Entail by Reverend William Mowat Cameron to Thomas Dishington Smith as institute or heir of entail, recorded G.R.S (Orkney & Zetland) 27 Aug. 1900, of 84 merks land of Muness, contains the following rights and burdens:

Together with the whole pro indiviso rights to the Scattald pertaining to the lands hereby disponed and hitherto possessed and used by me or my predecessors in the said lands and others or the tenants thereof and at present used by the other proprietors having a right to use the same in common with me; But reserving always to me and my successors in the Estate of Garth, of which the subjects hereby disponed form part right to fourteen of the tenants of the lands subjects and others at Uyeasound in the Parish of Unst belonging to me to take peats for the reasonable uses of their houses or holdings but for no other purpose whatsoever from the Mires of Ramnagoe on the portion of the Scattald adjoining the lands hereby disponed but declaring always that the said right of taking peats hereby reserved shall be used and exercised by my said tenants in accordance with the Garth estate regulations as at present in force; Reserving always to the said Thomas Dishington Smith as institute or heir of entail and the other persons or heirs of entail full power at any time not withstanding these presents and whole clauses thereof to enter into agreements with the other pro indiviso proprietors of the said Scattald hereby disponed for the division thereof either by mutual agreement between the said pro indiviso proprietors and the said Thomas Dishington Smith or the other persons or heirs of entail or otherwise as the said Thomas Dishington Smith and the other pro indiviso proprietors may mutually agree and for the purpose of carrying out the said agreement to grant or accept delivery of all deeds necessary for effectually carrying into effect such agreements which division if carried out by the said Thomas Dishington Smith as institute or heir of entail foresaid shall be as binding upon him as institute or heir of entail foresaids and upon the other persons or heirs of entail in all time coming as if made by the said Thomas Dishington Smith as a fee simple proprietor and with power also to the said Thomas Dishington Smith as institute or heir of entail foresaid and to the other persons or heirs of entail to institute and carry out to a conclusion any completed process for the judicial division of the said pro indiviso scattald or to concur with the other pro indiviso proprietors in doing so.

Agreement, in terms of the Ancient Monuments Acts 1913 to 1953, recorded G.R.S. (Orkney & Zetland) 21 Feb. 1956, between Jean Mabel Mary Dishington Smith or Dewar (hereinafter referred to as "the First Party"), James Bruce Dewar and Robert Hugh Dewar (hereinafter referred to as "the Second Party") and Minister of Works (hereinafter referred to as "the Third Party") whereby the First Party, with consent of the Second Party as heirs of entail, appoints the Third Party to be Guardian of Muness Castle with solum thereof and ground surrounding same being the subjects in this Title tinted blue on the Title Plan, contains also the following:

Declaring (First) that the Third Party, his representatives, workmen and others and members of the public visiting the said Castle shall have free right of access at all times to the said Castle and surrounding area of ground above described from the road or track from Uyea Sound through Muness to Wester-House and Scolla for which purpose the Third Party shall be entitled at his own expense to break open and form an entrance gate in the north east wall of the enclosure round said Castle; (Second) that the Third Party, his representatives and workmen shall have access on all necessary occasions over the First Party's surrounding lands to the outside faces of the enclosure walls for the purpose of maintaining and repairing the same; (Third) that the Third Party shall be entitled to retain the custody of all objects of historic, artistic or archaeological interest discovered by him or others within the said area of ground in the course of any works undertaken by him in pursuance of his powers under said Acts provided that the Third Party shall be bound to arrange for the disposal and display of all such objects in conformity with the recommendations of the Disposals (Finds) Committee set up by the Third Party to advise on such matters; (Fourth) that the said Third Party shall be entitled to fix exact from members of the public visiting the said Castle and retain such sums by way of admission charges thereto as he may in his sole discretion from time to time decide and (Lastly) that there shall be reserved to the First and Second Parties and their successors and those authorised by them free right of access at all times to the said Castle and area of ground and in the event of the Third Party providing a gate with a lock in the said north east enclosure wall which he shall be entitled to do at any time at his own expense, a key therefor shall be provided by him to the First Party.

#### Burden 3


